Proposed Budget for 2019-2020

Personnel

- All staff have signed the new Anti-Discrimination Policy. All adult staff members have been trained; teen employees have not yet been trained.
- All staff have written out their list of duties in preparation for the Know Your Library Trustee Training on Sunday, January 13. We will be working on the format of this presentation next week. We need trustee input to confirm our schedule.
- Since the Friends will not have a January used book sale, staff will be organizing one for the President's Day weekend on 2/16 and 2/17 during regular hours. We will also make an effort this weekend to publicize voter registration in time for residents to register before our April election.

Building & Equipment

There were no building issues in December and the weather has been very good to us.

Outreach

- I have agreed to reprise my workshop for librarians and teachers at the 2018 Banned Books Conference at Mount Saint Mary College with a presentation to Mount students and faculty on February 13. Our experience in dealing with a book challenge in 2003 lives on!
- Barron and Meg have been hard at work organizing a visit to Golden Hill and Seward by NYC graphic book author Gregg Shigiel in March. He will present either two or three sessions for grades 4 & 5 and 6,7 & 8 and will sign pre-ordered books at FPL, also.

Friends of the FPL

The Friends have no elected officers for 2018-19. As of 12/10, their treasury held \$5,391.51. Treasurer Rochelle Weiler is moving away this month. Former Treasurer Teri Gott has agreed to serve through June, but has not yet been elected to this position.
