MF: I sent you an email with the information from the executive order that the mayor (governor) sent out on Friday.

KL: Madelyn, while you read this could you mute everyone.

MF: OK, should I start again? So, the governor sent out a new executive order on Friday which was the first indication, real dates and information about how schools were to proceed with having the vote and because we are a school district public library that affects us as well. So, there are certain things that we know. All school budget votes are going to be on June 9 in NY state. All voting will take place by absentee ballot. The requirement for legal notices has been changed from the usual four to two and for candidates for school boards all they have to do is declare their intent to run by May 11 by filling out a form. Now, that last part of it does not seem to affect us because we already completed our trustee petition process by March 20. I think we are set on that aspect. Now, a new guidance came out from RCLS today urging us to have our votes with the school, on the school ballot, for the sake of efficiency. And that would be my recommendation that we do that because, you can see, did everyone see my email?

RK: Yes.

CL: Aye.

CL: Any opposed?

MF: OK, so this is how we used to do it, but we did establish our independence so what we would be talking about is just doing this for this year and next year we would go back to holding our election on our own. But, because of the cost

associated with running our own election, the legal notices, we already paid for legal notices for the election we cancelled, we would have to redo those. I had Martha look into some cost for the triple envelopes for absentee ballots and that would be over \$3,000. So already we are looking at \$6500. If we did decide to have an election on our own, we would have to have an attorney's input also and that would be another cost. Given the conservative tax levy we were putting up it would cost about 50% of that amount to run the election and as you know, our turnout last year was 130 so I don't think that is a good use of our money. So, going with the school on June 9 seems like the best alternative. I spoke to Superintendent Jehring and her team this afternoon. They were actually finalizing the first legal notice because they had to get it in the weekly newspapers, the same ones we use, the *Warwick Valley Dispatch* and the *Goshen Independent* and so they were very pressed for time, but because the standard language in their legal notice says "and other propositions as may be needed or necessary," something like that, she felt that covered our propositions. They have three proposition and we would be adding two to it. And when they do the next legal notice, the second one, our two propositions would be spelled out. So, if we go ahead and do this, on June 9 when Florida voters go to the school, well no, they are not going to the school, everyone is going to have absentee ballots, someone is going to be at the school to open that night. So, you would receive, as a voter, a ballot that would have all five propositions on it. We would not be paying for the printing, or the ballots or the legal notices. So of course, that would be saving us money.

NS: So, what are our two propositions? The budget and?

MF: And trustees.

NS: Oh, and trustees.

MF: And the election of two trustees.

NS: OK.

MF: So, in the guidance that came from RCLS today they are saying very definitely, even if we decided not to put up a budget, we still would have to have a trustee election.

CL: So that would still be the \$6500 to mail it out or would that just be one proposition on the school budget?

MF: OK, I'm saying \$6500 would be what it would cost us to do our own election by ourselves.

CL: I know and I'm asking can we just do the proposition for the trustees on the school budget?

MF: We could, but I don't think there is any point in not have the budget.

CL: No, I don't think so either. It was just a question.

MF: Yeah, yeah. They're waiting, I'm going to call Jan tonight with your decision and let them know.

CL: What do you guys think?

KL: Madelyn, will you oversee the verbiage that goes out on these ballots to make sure that our propositions and who we represent and the budget, etc., all those details are finalized before we to print?

MF: Well, what I will give them is the exact language that you approved back in January for those two propositions. So, I think Helen Arena at the school would be in charge of that so I would be planning on emailing her an attachment of the legal notice. So certainly, I can go over it with her on the phone and make sure it is exactly as we want.

KL: And another question, can you just appoint the trustees and just have the budget go to vote?

MF: Say again.

KL: Can we appoint the trustees and just have the budget go to vote?

MF: I think...I don't know. Jerry Nichols who was the author of the *Handbook for Library Trustees*, he says, he's very firm about this is NY State law that every library has to have an annual trustee election. There was some discussion of another library consulting an attorney and saying well, you could just not have the election and in July appoint the trustees. But, of course, in our case what would result was that next year we would have five out seven of you running on the same ballot. I don't think that is advisable.

KL: Good point.

MF: As it is you are staggered over the course of years.

NS: Grace's email indicated that if you didn't do the budget you still have to do the trustees.

MF: Right.

MF: OK.

CL: So how does everyone feel about rolling our budget vote back into the school budget vote and doing one ballot to be mailed out?

KL: I feel that with there being such a small number of things that people are going to be voting on that our piece is not going to get lost in this ballot that is going out. I hope that the school keeps it very simple, a few bullet points, a little bit of description and who and what. I feel like it is really our only best option right now. I mean we are talking about high dollar amounts right now to just be literally giving to the post office. I have no idea what's going to happen with our school taxes, property taxes and state taxes going forward. I don't want to add one more of bills with our tax levy and that amount of \$13,600 being cut out of next year's budget. So, my vote is to put it on the school budget on June 9th and let it roll that way.

CL: I agree. Anyone else?

DA: I agree also.

LF: I agree, well put Kevin.

NS: I don't think we have a choice. It is really foolish to spend the money to do it separately.

KL: I mean I'm already hearing from the school that they're cutting positions. They've given, I know one elementary school position got cut. They are giving incentives for early retirement. I know two people from the elementary school are going. Cuomo is talking about cutting school aid by 50% next year. I mean this is a scary time.

DA: And monies that we might have gotten from the legislators will probably be cut drastically, if we get any.

CL: Did we lose Stella?

DA: She is muted.

SK: I'm right here. I'm listening to everything you said. Thank you, I just muted you.

CL: Your little box disappeared when you muted.

SK: I'm here.

CL: Thank you. So, Madelyn, how does this read? A motion by blank seconded by blank to?

MF: hold the library's annual budget vote and trustee election on the school, on the FUFSD ballot on June 9, 2020. I think that will do it.

CL: No, I know, I'm thinking it makes more sense to see what happens with the budget vote because that is on here, Budget for 2020-2021. So that is going to reflect the changes, Madelyn, is that correct?

MF: Yeah, we have to see what happens with the budget on the ballot and there would be no need to change the budget unless you wanted to change something as we would normally change a budget moving monies from one place to another.

NS: Has RCLS made any comments on when they think about reopening or are they just going to follow the school right now?

MF: According to the governor's press briefing today, he listed, he had four categories of businesses, and the first was construction business could open right away and this is provided he lifts, after May 15th, the NY PAUSE. I think the second was retail, third was restaurants and the fourth was cultural arts & entertainment and education so I am 99% sure we would fall into that fourth category. So, we really don't know and that's dependent on the four benchmarks he set out about how many cases, hospitalizations and all that. And further it depends on what part of the state you are in. We are in the Mid-Hudson block that they have carved out and that included Rockland and Westchester. So, you know I think that is going to make it maybe later than our neighbors to the north. So, there is a lot we just don't know.

NS: OK.

CL: OK, so we can discuss the budget more on a future agenda as we know more. OK.

MF: Oh, Cecelia there was one more thing. I'm sorry.

CL: That's OK.

MF: OK, because the budget vote would then be on June 9th a Tuesday, I just wondering if we would want to push our June meeting from June 8th, the Monday, to the following Monday, June 15th?

CL: So, we can discuss what happened?

MF: Right.

CL: That makes sense to me.

KL: Is there going to be somebody from the library that would help with the tallying of the votes? Or is that handled by an election committee through Orange County?

MF: I am assuming that it would be the usual process. The school hires election inspectors just as we do.

KL: OK. You don't need to be at the school to represent?

MF: Oh, I would probably go that evening, yeah.

NS: I thought our meeting would be the first?

MF: Oh, I'm sorry. Yes, you're right, Nancy. I'm looking at the Friends' meeting. OK, so that would be moving our June meeting from June 1st to June 15th.

DA: I have an RCLS board meeting that night.

RK: What is the reason for moving it?

MF: So, we can actually address any change that we might need to make following the June 9th election.

CL: Yeah, if the budget gets defeated.

RK: OK.

NS: Can we call a special meeting if it is a problem?

KL: I was just going to say that.

MF: We could do that, too. We could stick to June 1st and then call a special meeting after June 9th.

NS: Right, if there's a problem.

CL: Diane, can you make the first?

DA: Say that again.

CL: Can you make it June 1st?

DA: Yeah, June 1st I can make it.

Inaudible sounds.

KL: OK, then how will I find out if I've been elected? You guys going to send (the rest is inaudible)

MF: Well, if you go to the school on Tuesday, June 9th when they are counting votes, at some point they are going to announce the results of the election and if you are not a night owl we could call you or come down and knock on your door or?

MF: We'll see.
