- Certificate of Public Library Administration Class RCLS in conjunction with Mid-Hudson Library System is looking to offer the Certificate of Public Library Administration Class in early 2024. The class is designed to develop and enhance the management skills and credentials of professional librarians working within the public library sector, and to train the leaders of tomorrow.
