- Barron's September Program Report will be available at the meeting.
- Barron submitted our annual Summer Reading @ NY Libraries' worksheet. In comparing this summer to last summer, we saw a slight increase in the number of programs to 53 up from 51 the previous summer. Once again, the real increase was in attendance. We had 1608 children attend programs this summer compared to 1,368 for 2022. Registrations for the Summer Reading Clubs saw a slight increase at 96 children and 20 teens this summer compared to 82 children & 12 teens for 2022.
